*Karlheinz Deschner has written thus far written nine Volumes, entitled the "Crime History of Christendom" (Kriminalgeschichte des Christentums), an exposé primarily about the Catholic Church, its councils, the popes, its wars, the crusades; but also about the Reformation, i.e. the *real* Martin Luther.) Each volume is 500+ pages with detailed reference sources and quotations.) The final work is estimated to be 10 volumes).

*Ref. Local court: In Germany the total income tax paid includes 7-9% Church tax, collected by the German IRS. This must be paid, if one is either Catholic or Protestant; the only way out is, going to the Local Court, where the individual officially decrees their exit from the church, then the income tax is reduced by either of the above indicated percentage. (my father was protestant, never went to church, but for many years he hadn't paid church taxes, he had to pay or the church threatened with a collection agencies).

The figures left, represent the first detailed publication of the income, subsidies and taxes given and are received by the Catholic Church – tax free, of course. Additionally a

Cardinal in Germany, receives the equivalent salary like a minister in the German Federal Government; he lives in FREE an equivalent villa, and is driven in a FREE chauffeured Mercedes, i.e. model 500. All these conditions were part of the between Hitler and the Vatican: the Concordat.

What concession did the Vatican make: The pope can only name a Cardinal or Archbishop, after he has received the approval from the German Chancellor, or in case of bishops, the Prime Ministers (Governors) of the German States; ensuring compliance with German political policies.
